



# THEATRE ARTS PROGRAM CONSENT AND RELEASE



I give permission and desire for my child, \_\_\_\_\_ to participate in the Fort Worth Independent School District’s Theatre Arts program which includes Technical Theatre.

I understand that participation in the Theatre Arts program may include activities that bring with them a risk of serious injury. Students may utilize scaffolding, ladders, electrical equipment, and carpentry materials including, but not limited to, saws, paint, and other chemicals. **I understand that my child’s participation in the Theater Arts program requires my agreement and acknowledgment to the following:**

1. All participating Theater Arts program students must adhere to all policies, regulations, and rules of Fort Worth ISD, the student’s campus, and the Theater Arts program.
2. Theater Arts program students may be supervised by representatives of Fort Worth ISD and its volunteers. I further authorize these individuals to transport my child by vehicle, bus, ambulance, medical helicopter, or any other mode of transportation during the Theater Arts program if such transportation is deemed necessary for the health and wellbeing of the student.
3. Every effort will be made to contact the parents/guardians of a student in the event of an emergency, and, if possible, before any medical treatment is administered. In the event of an emergency or if the parents/guardian cannot be notified, I hereby give permission to the Fort Worth ISD and its employees and volunteers to secure proper treatment for my child. If necessary, this includes selection of physicians and medical treatment facilities that are then authorized to perform such medical treatments as deemed necessary to protect the health of my child. I further understand and acknowledge that neither Fort Worth ISD nor any of its employees, agents, or volunteers will be responsible for paying for any such medical treatment.

In consideration of the opportunity and privilege of participating in this program, the receipt and sufficiency of which is hereby acknowledged, I, by my signature affixed below, individually and by next friend of the above named child, acting for myself, my minor child, my agents, heirs, beneficiaries, trustees, executors, successors, assigns, administrators, and legal representatives, do hereby **RELEASE, ACQUIT AND FOREVER DISCHARGE** the Fort Worth Independent School District, all of its employees, agents, trustees, volunteers, and legal representatives, in their representative, official, and individual capacities, of and from any and all charges, complaints, grievances, claims, demands, causes of action, damages, loss, or expense, of whatsoever kind or character, in tort (**INCLUDING NEGLIGENCE OR NEGLIGENT OMISSION**), or in contract, that are created by or arise under state and federal statutes, constitutions, or the common law, whether known or unknown, which may in any manner arise from or relate to participation in the Theater Arts program. I hereby waive my rights to institute any action, claim or suit against and/or recover compensation, benefits, or damages from the Fort Worth Independent School District and/or the above-described persons and entities, and covenant and agree not to sue any such persons or entities regarding such claims in any court or tribunal and not file or aid in the institution or prosecution of any action, lawsuit, or cause of action (whether or not by direct action, counterclaim, cross-claim, or interpleader) regarding any claim released herein. I understand that nothing in this consent and release alters or waives any immunity or other protection afforded to the Fort Worth Independent School District by state or federal law.
